1. BACKGROUND

The Government of Punjab has received Credit No. 7043 - PK from the International Development Association (IDA) towards the cost of the Punjab Affordable Housing Program (PAHP). The Program is being implemented through a Program Management & Implementation Unit (PMIU) under the Housing Urban Development and Public Health Engineering (HUD&PHE) Department with Urban Sector Planning & Management Service (Pvt.) Ltd. (The Urban Unit - Government of Punjab) and PHATA (Punjab Housing and Town Planning Agency) as co-implementing agencies.

The PMIU of the World Bank-funded Punjab Affordable Housing Program (PAHP) invited quotations for the Procurement of works for **Renovation & Furnishing of PAHP-PMIU Office (New Hall).** The procurement was processed through Request for Quotations (RFQs) method in accordance with World Bank Procurement Regulations 2020. The estimated cost of the said procurement is PKR. 21.00 Million (inclusive of all applicable taxes)

2. INVITATION FOR QUOTATIONS

The Request for Quotations (RFQs) was uploaded on the website of PAHP on 28.02.2025 with the closing date of 14.03.2025 at 09:30 AM.

3. SUBMISSION OF QUOTATIONS

The date and time for submission of quotations was fixed for **14.03.2025 at 09:30 A.M**. The quotations from the following seven (07) firms were received on the fixed date and time in response to Request for Quotation; (receipt record is attached as **Appendix-1**):

- vii. must provide firm/company profile.
- viii. must have three (03) years of relevant experience in supply of similar nature of Services.
- ix. attaches Copies of three (03) verifiable PO/WO/Contracts showing successful supply of similar Services during the last three (03) years compared to determine the lowest evaluated price/s.


